General Definition of Work:

The Distribution Technician Trainee is responsible for operating a variety of light to heavy equipment. Performs a variety of skilled and semi-skilled activities in maintaining, repairing, inspecting, and operating the Laguna Madre Water District (LMWD) water systems.

Essential Job Functions, Duties and Responsibilities:

- Performs excavating of soil and assists other distribution staff in installing and repairing water utility systems.
- Operates and transports heavy equipment such as; dump trucks, backhoes, and electronic locating devices.
- Inspects and monitors equipment to maintain adequate operating conditions.
- Selects the proper cleaning tools for the maintenance of water lines.
- Performs manual tasks involving physical and endurance under variable weather conditions.
- Assists with minor/major repairs or replacement of water equipment.
- Performs other related duties as assigned to enhance the overall operations and services of the Distribution Department.
- Must adhere to all safety policies and procedures.

Requirements:

- Job requires a diploma from an accredited high school or GED equivalent.
- Position requires a valid, TX Class C driver's license.
- Must be able to read, write, and speak English.
- Must be able to obtain a class "C" Distribution Certification issued by TCEQ.
- The district may hire a distribution Technician with no previous work experience.
- Must be able to obtain a Commercial Driver's License within six months of employment.
- Must be able to work stand-by rotation upon acquiring the Commercial Driver's License.

Work involves walking at job sites, driving, lifting, climbing, and other physical demands.
